

## 2ND COLLECTION DESCRIPTIONS

### **INITIAL OFFERING (Parish)**

Helps church with expenses of this year's Offering envelopes.

### **B.C. CATHOLIC (Archdiocesan)**

Supports parish in its circulation of the official newspaper of the Archdiocese of Vancouver. This collection is retained by the parish to defray the parish costs of distribution.

### **SHARE LENT (National)**

Supports Canadian Catholic Organization of Development and Peace fight poverty in third-world countries and foster international justice.

### **ST. JOSEPH'S SOCIETY FOR INFIRMED & RETIRED PRIESTS (Archdiocesan)**

Supports priests in their retirement years or ill health.

### **NEEDS OF THE CHURCH IN THE HOLY LAND (National)**

Supports Christians in the Holy Land.

### **WORK OF VOCATIONS (Archdiocesan)**

Supports seminarians studying to become priests for the Archdiocese of Vancouver.

### **POPE'S PASTORAL WORKS (International)**

Supports the charities of the Holy Father.

### **CATHOLIC MISSIONS IN CANADA (National)**

A National collection that provides support for over 600 remote and poor mission communities in the north and across Canada.

The parish bursary fund for families attending OLA Elementary that are experiencing financial hardship.

To assist families who are experiencing financial hardship for tuition at OLA Elementary and Archbishop Carney Secondary High School.

### **HOME MISSIONS (Archdiocesan)**

Offsets the cost of maintenance of all buildings in the parish, and helps defray the debt incurred in the construction of the current Church building.

## PAD TERMS & CONDITIONS

### ACCOUNT HOLDER'S AGREEMENT

I/We agree to participate in the Pre-Authorized Debit (PAD) Plan for Sunday offerings and 2nd Collection offerings for the dates stipulated on this sheet. I authorize the Parish to automatically renew and carry over the offering amounts designated in this form to the next calendar year unless I notify the parish office otherwise.

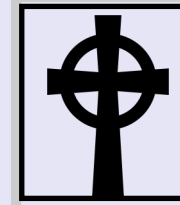
I/We acknowledge that the authorization is provided for the benefit of the Payee and the Processing Institution and is provided in consideration of the Processing Institution agreeing to process debits against my/our account as list above (the "Account") in accordance with the rules of the Canadian Payments Association.

I/We agree that any direction I/we may provide to draw a Personal PAD, and any Personal PAD drawn in accordance with the Agreement, shall be binding on me/us as it is signed by me/us, and in the case of paper debits, as if they were cheques signed by me/us. I/We may revoke or cancel this agreement at any time upon notice being provided by me/us in writing to the Payee 10 business days prior to the next due date of the PAD. This date is the 1st of the month for Sunday offerings and the 15th of the month for 2nd Collection & Feast Days. I/We agree that delivery of this Agreement to the Payee constitutes delivery by me to my Financial Institution. I agree that the Payee may deliver this Agreement to the Payee's financial institution and agree to the disclosure of any personal information which may be contained in this Agreement to such financial institution.

I/We agree that my Financial Institution is not required to verify that any Personal PAD has been drawn in accordance with this Agreement, including the amount, frequency and fulfillment of any purpose of any Personal PAD. I/We agree that the information contained in the Authorization may be disclosed to the Bank of Montreal as required to complete any PAD transaction. The Payee will provide to me/us written notice of the amount to be debited (the "Payment Amount") and the date (s) on which the Payment Amount debited will be posted to my/our Account (The "Payment Date") at least 10 calendar days before the Payment Date of the first PAD and such notice shall be provided every time there is a change in the Payment Amount or the Payment Date. I/We warrant and guarantee that all persons whose signatures are required to sign on the Account have signed this Agreement below. I/We agree to comply with the rules of the Canadian Payments Association or any other rules or regulations which may affect the services described herein, as may be introduced in the future or are currently in effect and I agree to execute any further documentation which may be prescribed from time to time by the Canadian Payments Association in respect of the services described herein. I/We understand and agree to the foregoing terms and conditions.

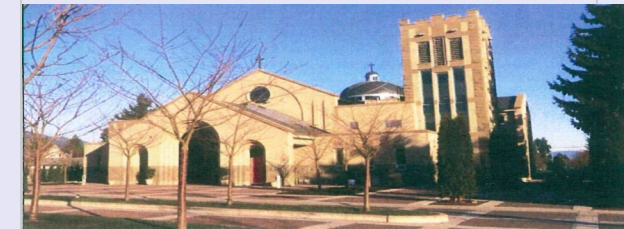
